COOKIE POLICY

DRD presents the following explanations to the attention of our customers and third parties who use our websites and/or mobile applications in order to fulfill the obligation to inform arising from Article 10 of the Personal Data Protection Law No. 6698 ("KVKK"). DRD reserves the right to update this Explanation on the Protection of Personal Data at any time within the framework of changes that may be made in the legislation in force. There are regulations in various laws on the use of personal data of our customers. First and foremost, the principles of protection of personal data are determined by the KVKK. In addition, the Law No. 6563 on the Regulation of Electronic Commerce also contains provisions on the protection of personal data. The Turkish Penal Code No. 5237 also provides for criminal sanctions in some cases for the protection of personal data.

On the other hand, it is necessary to collect and use data in order to fulfill our obligations arising from the Law No. 6502 on Consumer Protection and the Regulation on Distance Contracts.

DRD may use cookies when you visit our websites www.drd.com.tr, www.onecar.com.tr, www.filomatikhizliteklif.com and www.hayatiemniyetliyasa.com, including media channels, mobile site, mobile application and other media platforms to customize the site and improve your experience.

USE OF COOKIES

A "cookie" is a string of information, mostly letters and numbers, that is stored on your computer and identifies a unique user, which is stored on the internet browser or hard disk of the device being used, allowing the device in question to be detected. Your browser provides this unique user information when you make any request through the site. Through cookies, your usage and visiting habits, session information, past transactions and browsing information on the site are processed.

We use these cookie files to make the website user-friendly, more effective and more reliable. Cookie files do not contain personalized information.

HOW DO YOU CONTROL COOKIES?

Many browsers are set to automatically accept cookie files. When accessing our web pages, when cookie files are accepted according to your browser settings, you consent to the use of these cookie files. However, you also have the possibility to set your browser so that only some cookie files are accepted or rejected, or rejected altogether, with cookie files being displayed before they are saved.

You can enable or disable cookies by changing the settings of your browser. However, if you disable cookies, you may not be able to use some interactive features on the site.

TYPES OF COOKIES

We use two types of cookies across our sites: session cookies and persistent cookies. Session cookies are temporary cookies and are only valid until you close your browser. Persistent cookies remain on your hard disk until you delete them or until they expire (how long cookies remain on your device will depend on their "lifetime").

Web Analytics Cookies

Web analytics cookies track where users access the Site, how they interact with the Site and how they move around the Site. These types of cookies provide us with information about which features on the site work best and how the site can be improved. DRD uses Google Analytics, a web analytics service. Google Analytics uses cookies to analyze how users use the website, mobile application and/or mobile site with statistical information/reports. Advertising Cookies

Advertising cookies are placed on your computer by advertisers and ad servers to display advertisements that are more likely to appeal to you. Security Cookies

Security cookies help identify and prevent risks. These types of cookies are used to identify users and prevent unauthorized access to data.

Site Management Cookies

Site administration cookies are used to maintain your identity or session so that you are not logged out unexpectedly and to retain the data you enter on subsequent pages. These types of cookies cannot be turned off separately, but you can turn off all cookies in your browser.

Third Party Cookies

Third party cookies are placed on your computer by companies that run some of the services we provide. These cookies enable third parties to collect information about you and track certain information. You can manually turn off these types of cookies in your browser.

You can use the following methods to allow and reject cookies:

Google Chrome	You can allow or block cookies from the "Cookies" tab by clicking on the "lock sign" in the address section of your browser.
Internet Explorer	You can manage cookies as "allow" or "disallow" by clicking the security tab in the "Tools" section at the top right of your browser.
Mozilla Firefox	Click on the "open menu" tab in the upper right corner of your browser. You can manage cookies using the "Privacy and Security" button by clicking on the "Options" image.
<u>Opera</u>	You can manage cookies from the "Cookies" section by selecting "Advanced" in the "Preferences" section of your browser.
<u>Safari</u>	You can select the "safari" tab in the "Settings" section of your phone and manage all your cookies in the "Privacy and Security" section.

OTHER TRACKING TECHNOLOGIES

In addition to cookies, web beacons, pixel tags and other technologies may be used to personalize the Site and improve the experience. A "web beacon" or "pixel tag" is a small object or image embedded in a website or email. They are used to collect data on how many users have visited a particular website or viewed an e-mail and other statistical data. Web beacons and pixel tags only collect a limited set of data. These include the number of cookies, when and on what date the page or email was viewed, and the description of the page or email on which they are located. Web beacons and pixel tags cannot be rejected, but their use can be restricted by using cookies that interact with them.
